

2016 Report to Congress: State Safety Oversight (SSO) Program

The available amount apportioned to States is based on funding authorized under The Moving Ahead for Progress in the 21st Century Act (MAP-21), (Pub. L. 112-141, 2012). Since MAP-21 expired on September 30, 2014, Congress continued FTA's transit assistance programs, including the State Safety Oversight (SSO) grant program, through the Consolidated and Further Continuing Appropriations Act (Pub. L. 113-6, 2013), and through the Highway and Transportation Funding Act of 2015 (Pub. L. 114-21), which extended Federal funding through July 31, 2015, and, most recently, through the Fixing America's Surface Transportation (FAST) Act (Pub. L. 114-94, 2015), which extends funding through September 30, 2020. Funding is apportioned according to the formula developed in the March 10, 2014 Federal Register notice (79 Fed. Reg. 13380).
