

## **Safety Audits**

- The APTA bus and rail safety audit programs use Safety Management Systems (SMS)-based criteria to reflect requirements from the FTA, including those published in the Public Transportation Agency Safety Plan (PTASP) final rule
- Through APTA's Safety Audit Program, agencies learn how to implement SMS, meet APTA Industry Standards, and prepare for SSO and FTA audits
- Over 20 transit agencies in the program, including bus, rail and commuter rail


