Earlier this week, we hosted the <u>FTA Joint State Safety Oversight (SSO)</u> and Rail Transit Agency (RTA) Virtual Workshop and welcomed nearly 300 stakeholders including representatives from 31 SSO programs and over 51 RTAs. This year's virtual workshop focused on effective working relationships among SSOs and RTAs, combating cyber threats in the transit industry, and current transit safety policy and guidance updates. If you joined us, thank you! We hope you found the virtual workshop insightful and helpful in your role in transit safety. Each year we aim to improve the workshop as we work together to advance safe, reliable and equitable transit service. We are reviewing your evaluations and will incorporate your feedback into next year's workshop. Please stay tuned for a recap of the virtual workshop in next month's newsletter.

On September 28, 2021, FTA <u>announced</u> a <u>Request for Information (RFI) on Transit Worker</u> <u>Safety</u> seeking the public's input to help make transit safer for frontline transit workers. Through the RFI, FTA is soliciting public input regarding safety topics that affect transit workers in two areas: rail transit roadway worker protection and transit worker assault prevention. FTA will use this information to evaluate potential actions to mitigate the identified safety risks for transit workers. Your feedback is critical to help FTA gain an understanding of the current safety challenges transit workers face. The deadline to submit comments is November 23, 2021.

We would like to thank the public for responding to our most recent <u>RFI on Transit Safety</u> <u>Concerns</u> that will inform FTA's identification of transit safety concerns relevant to the transit industry. Currently, we are reviewing the public's feedback to identify and proactively mitigate safety concerns impacting the transit community.

Finally, the monthly reporting received from the <u>FTA Transit COVID-19 Response Program</u> <u>Information Collection</u> continues to provide us with valuable information we use to better understand transit agency response and recovery. Additional details are included on page two of this newsletter.

COVID-19 Resources and Updates


FTA continues to provide <u>updated resources</u> on COVID-19. The following resources are available:



Key Takeaways as of August 31, 2021





Percentage of Agencies with Suspended or Reduced Service




Transit Worker Vaccination Rates Over Time

FTA Announces Request for Information on Transit Worker Safety



On September 28, 2021, FTA <u>announced</u> a <u>Request for Information (RFI)</u> soliciting public input on potential transit worker safety mitigations in two areas: rail transit roadway worker protection and transit worker assault prevention. Your feedback is critical to help FTA gain an understanding of the current safety challenges transit workers face. The deadline to submit comments is November 23, 2021.

The transit industry's input is critically important in identifying and proactively mitigating safety concerns. FTA will use this information to

evaluate potential action to mitigate identified safety risks for transit workers. On October 12, 2021, FTA hosted a webinar to discuss the RFI. The webinar <u>presentation</u> and <u>recording</u> are available on the FTA website.

FTA Publishes New Bus and Rail Safety Data Reports

FTA recently published the <u>2021 Bus and Rail Safety Data Reports</u> which inform the public and the transit industry about the state of transit's safety performance across the nation. On October 5, 2021, FTA hosted a webinar to provide an overview of the new Bus and Rail Safety Data Reports. The webinar <u>presentation</u> and <u>recording</u> are available on the FTA website. Bus Safety Data Report (BSDR)


The BSDR analyzes the 2008-2018 safety and security event data transit agencies reported to the National Transit Database.

This <u>one-page BSDR summary</u> provides an overview of the bus transit data analysis and includes key takeaways from the full BSDR.

Rail Safety Data Report (RSDR)

The RSDR analyzes the 2007-2018 safety and security event data submitted to FTA by State Safety Oversight Agencies.

This <u>two-page RSDR summary</u> provides an overview of the rail transit data analysis and includes key takeaways from the full RSDR.



Fiscal Year 2022 TSI Safety Training

<u>Registration</u> is open for Transportation Safety Institute (TSI) safety training courses for transit personnel. These courses also support FTA grantees subject to the <u>Public Transportation Safety Certification Training Program (PTSCTP) regulation</u> with initial training and refresher training requirements. The <u>Fiscal Year 2022 TSI Training Schedule</u> is also available. New this fiscal year, all rail PTSCTP courses will be delivered virtually.

Dana Jenkins Transportation Specialist, Office of Program Oversight, Office of Transit Safety and Oversight, FTA

Two of my primary duties are to manage purchase requisitions for FTA's oversight review contracts and provide financial planning and monitoring for the oversight review programs.
