On October 25, 2021, FTA issued a Public Transportation Agency Safety Plan (PTASP) industry survey to the 755 applicable States and agencies that have certified compliance with the PTASP regulation (49 CFR Part 673) and the 31 State Safety Oversight Agencies. If you have not already done so, please take a few moments to respond to the survey questions before it closes on November 24, 2021. Your feedback is invaluable and will assist FTA to determine priorities for new PTASP technical assistance resources in Fiscal Year 2022. Thank you to those who have already submitted feedback.

On October 26, 2021, FTA published the calendar year 2022 Drug and Alcohol Random Testing Rates for transit employers. The minimum random drug testing rate will remain at 50 percent, and the random alcohol testing rate will remain at 10 percent. FTA requires drug and alcohol testing for transit employees performing safety-sensitive functions and for employers to submit annual drug and alcohol testing reports by March 15 of each year.

We would also like to thank you for responding to our most recent Request for Information (RFI) on Transit Worker Safety that focuses on rail transit roadway worker protection and transit worker assault prevention. The RFI closes on November 23, 2021, so if you have not had an opportunity to submit your feedback, please do so today. FTA will use your feedback to help gain a better understanding of the current safety challenges impacting transit workers.

# FTA Transit COVID-19 Response Program Information Collection Update


Key Takeaways as of September 30, 2021


#### Transit Worker COVID-19 Positives and Fatalities





### Percentage of Agencies with Suspended or Reduced Service




#### Transit Worker Vaccination Rates Over Time

(MDOT), Maryland Transit Administration (MTA), National Transportation Safety Board (NTSB), New York Metropolitan Transportation Authority (MTA), Sound Transit, Washington State Department of Transportation (WSDOT) and the Wisconsin Department of Transportation (WisDOT) shared best practices on effectively managing working relationships between oversight agencies and the rail agencies and resources to strengthen rail transit safety.

Workshop highlights included the Cybersecurity: Cyber Threats in the Transit Industry; State Safety Oversight and Rail Transit Agencies Effective Working Relationships; and Accident Notification and Investigations sessions. Participants also benefited from the virtual knowledge exchange opportunity at the end of day one where they engaged in discussions with their peers. # Operation Lifesaver Awards Rail Safety Grant Funding to Six Transit Agencies in Four States




Operation Lifesaver, Inc. (OLI) awarded \$107,000 in grant funds to six transit agencies in four states for rail transit safety public awareness and education projects and campaigns. The winning projects include initiatives in communities with operating or planned rail transit systems such as commuter rail, light rail, subway and streetcar service. OLI is a non-profit organization and leader in rail safety education committed to preventing collisions, injuries and fatalities on and around railroad tracks and highway-rail grade crossings.

The selected grantees of the funding and their projects include: <u>Brightline</u> in Miami, Florida; <u>Long Island Rail Road</u> in New York, New York; <u>Metro-North Railroad</u> in New York, New York; <u>Metro Transit</u> in Minneapolis, Minnesota; <u>New Orleans Streetcar (RTA)</u> in New Orleans, Louisiana; and <u>SunRail</u>, Sanford, Florida.

The grant amounts range between \$7,000 and \$20,000 and require each agency to provide a 25 percent match. The approved grants were awarded through a competitive process, based upon criteria such as key safety messages, target audiences and evaluation methods. 
## Data Spotlight: Locations of Slip, Trip and Fall Events (Rail)

Reviewing national safety data sets may help transit agencies analyze safety hazards and establish safety performance targets in accordance with their <u>Agency Safety Plan</u>. This month's spotlight reviews National Transit Database (NTD) rail transit data for "slip, trip and fall" events from January 2017 to June 2021. FTA requires every Rail Transit Agency (RTA) to provide the NTD with a major safety event report when the resulting consequences include a fatality, a serious injury or non-serious injuries to multiple people occurring on agency property. This excludes events resulting from medical conditions or occurrences in administrative buildings. Also excluded are non-major slip and fall events that result in a single non-serious injury.



Since 2017, RTAs have reported 128 major slip, trip and fall events, accounting for 20 fatalities, 89 serious injuries and 114 non-serious injuries. Many of these events had significant consequences—60 percent resulted in either a serious injury or a fatality. Most of the 128 slip, trip and fall events occurred in rail stations, with 45 percent on escalators, 15 percent on stairways, 10 percent on platforms and 9 percent in other station areas. Events on the right-of-way accounted for another 10 percent, while 6 percent happened on trains. The remaining 4 percent were on other agency property. A detailed breakdown of the most common locations of slip, trip and fall fatalities, serious injuries, and non-serious injuries is presented below.

Another source of rail safety data is the <u>2021 FTA Rail Safety Data Report (RSDR)</u>, which presents rail transit safety and security event data for all 2007–2018 events FTA required SSOAs to investigate. The 2021 RSDR presents both raw data and rates per Vehicle Revenue Mile (VRM), which may indicate patterns of rail safety performance. Questions about this Data Spotlight or the RSDR? ## FTA Employee Spotlight: Elliott Shepherd



**Elliott Shepherd**Chief, Program Operations Division, Office of Transit Safety and Oversight, FTA

How would you explain your job to someone you have never met? As the Chief of the Program Operations Division for FTA's Office of Transit Safety and Oversight, I am responsible for accident investigations, inspections, FTA Regional Safety Officers and emergency management. Together with my FTA colleagues, we work to help people find solutions as we work toward safer transit systems across America.

What were you doing prior to this role? In my most recent role, I was a Program Manager for Longevity Consulting where I managed multiple audit teams conducting Triennial Audits, including reviewing all documents related to State Safety Oversight Reporting and using the 49 CFR Part 674 Certification Toolkit. Prior to that, I was a Project Manager at ABS Group where I supported the Federal Railroad Administration (FRA) with Positive Train Control (PTC) safety plans reviews. Our team of auditors reviewed documents related to the PTC safety plans for regulatory compliance and I provided expertise, guidance and written opinions related to the completeness of the PTC safety plans and its component parts. I also was the Chief Operating Officer for

SunRail, where I was responsible for the daily operation of this Central Florida commuter rail. Our team successfully completed the system-wide installations of PTC. I have also worked as the Staff Director at the FRA where I led security, emergency preparedness and accident investigations. Our team directed FRA's response to National Transportation Safety Board recommendations, assigned investigations and coordinated information from FRA Regions and the railroads.

What is the one recommendation you would make to new professionals getting started in the transit industry? Ask yourself "Are you passionate about transit?" If so, find a way to get there, learn everything you can from how it works to how it gets funded and everything in between.

What is your favorite form of transportation and why? Railroads. The country was built with the help of railroads and they are entrenched in our history. Engineers found ways to get rail across the water, through mountains and across the land to connect and move people and goods—they still do, and in a more efficient manner than just about any other means we have. Through the access of railroads, people can find good jobs, explore new places, work toward their dreams and achieve financial security for their families.

When you were a child, what did you want to be when you grew up? I wanted to be an engineer working for a railroad, directing train operations, transporting both people and freight (like oil and gas)—safely and on time.

If you could learn any skill, what would it be? I would learn multiple languages, which would allow me to communicate with people, better understand their unique cultures and backgrounds and find new connections.

What is the bravest thing you have ever done? I volunteered with the FRA to go on a 12-month detail to Afghanistan to help build capacity to support a future Afghanistan in a global economy.

Which holiday is your favorite and why? Thanksgiving because it is a time to slow down and enjoy time with family and friends.

## FTA Publishes Calendar Year 2022 Drug and Alcohol Random Testing Rates



FTA is required annually to publish the <u>random testing rates</u> for transit employers subject to the requirements of <u>FTA Drug and Alcohol Testing regulation</u> (49 CFR part 655).

Effective January 1, 2022, as mandated by its regulation, FTA will maintain the required minimum rate of random drug testing at 50 percent of covered employees for recipients of FTA Urbanized Area Formula Program Grants (49 U.S.C. § 5307), Capital Investment Grants (49 U.S.C. § 5309), Formula Grants for Rural Areas (49 U.S.C. § 5311) and Grants for Buses and Bus Facilities (49 U.S.C. § 5339).

The testing rate remains at 50 percent because the industry has been unable to lower the rate of positive violations below 1.0 percent for two consecutive years. The minimum random alcohol testing rate also will remain at 10 percent.

For calendar year 2022, FTA determined that the random drug testing rate for covered employees will remain at 50 percent based on a verified positive rate of 1.08 percent for calendar year 2020. Further, FTA determined that the random alcohol testing rate for calendar year 2022 will remain at 10 percent, because the violation rate again was lower than 0.5 percent for calendar years 2019 and 2020. The random alcohol violation rates were 0.16 percent for 2019 and 0.17 for 2020. FTA requires drug and alcohol testing for transit employees performing safety-sensitive functions and for employers to submit annual drug and alcohol testing reports by March 15 of each year.
