## **Public Transportation Agency Safety Plan Updates**

- 100% of Transit Agencies and States are certified with Public Transportation Agency Safety Plans (PTASP) in place by the July 20, 2021 deadline.
- PTASP Technical Assistance Center continues to help with PTASP implementation, reviews and updates.
- PTASP Annual Survey: October 25-November 24, 2021
  - 429 responses from Transit Agencies and States
  - 33 responses from State Safety Oversight Agencies

### **Transit Worker Safety Request for Information**

## Request for Information Quick Facts

Date Open: September 24, 2021 Date Closed: November 23, 2021

Audience: Public (industry, transit providers, transit users, researchers, contractors, etc.)

Purpose: Solicit public input regarding transit worker safety mitigations related to roadway worker protection (RWP) programs and transit worker assault prevention

#### **Scope of Questions:**

- Types of redundant protections
- RWP and transit worker assault prevention best practices
- Minimum requirements and recommendations
- Information, data and technology

FTA received 47 responses, representing at least 20 States and the District of Columbia



= indicates the number of responses received from commenters located in that State



### **Entry-Level Driver Training Final Rule**

- The Entry-Level Driver Training (ELDT) was published in 2016, mandated by the Moving Ahead for Progress in the 21st Century Act (MAP-21)
- Set a Federal standard for mandatory training of entry-level drivers
  - Establishes minimum training requirements entry-level drivers and training providers must meet
  - States may have requirements that exceed Federal requirements
- Compliance Date: February 7, 2022
- Established the need for the Training Provider Registry (TPR)



### **Entry-Level Drivers-Who Is Covered?**

The ELDT regulations establish new minimum training standards for entry-level drivers. This includes individuals applying for:

A Class A or Class B commercial driver's license (CDL) for the first time

An upgrade of an existing Class B CDL to a Class A CDL

A hazardous materials (H), passenger (P), or school bus (S) endorsement for the first time

The rule does not cover individuals for whom States have waived the CDL skills test under 49 CFR 383.



### **COVID-19 Vaccine Access Outreach**

- We saw a 30.8% increase in the number of transit worker positive cases (20,660 new cases in December 2021).
- The transit worker vaccination rate rose to 74% (among agencies reporting this data point); this percentage now exceeds the national adult vaccination rate.

## **TSA Federal Mask Requirement Updates**

- The Transportation Security Administration (TSA) extended the face mask requirement through March 18, 2022.
- Range of Penalties:
  - \$500-\$1,000 for first offenders
  - \$1,000-\$3,000 for second offenders
- Resources:

## Implementing the Bipartisan Infrastructure Law Requirements

- FTA is working diligently to implement the changes required by the Bipartisan Infrastructure Law to enhance transit safety.
- These changes include enhancing the State
   Safety Oversight Program by strengthening
   rail inspection practices, provisions to address
   assaults on transit operators, and helping
   ensure safe and equitable access to transit.
- FTA will provide information regarding the implementation of these new provisions as quickly as possible.

# FTA Reestablishes the Transit Advisory Committee for Safety

- On January 18, 2022, FTA announced its intent to reestablish the Transit Advisory Committee for Safety (TRACS).
- TRACS has provided FTA with valuable recommendations for over 10 years on transit safety and other issues as determined by the Secretary of Transportation and the FTA Administrator.
- A Federal Register Notice soliciting membership nomination will be published in the coming weeks.
