PTASP NPRM and Bipartisan Infrastructure Law

- The PTASP NPRM incorporates updates from the Bipartisan Infrastructure Law
- Some requirements in the Bipartisan Infrastructure Law are self-effectuating and are applicable
 - As it relates to training, Section 5307 recipients that serve large urbanized areas must:
 - Add maintenance personnel as personnel that must participate in the agency's comprehensive safety training program
 - Ensure maintenance personnel, operations personnel, and personnel directly responsible for safety complete de-escalation training

Public Transportation Safety Certification Training Program (PTSCTP) Regulation

- 49 CFR Part 672 establishes a uniform safety certification training curriculum and requirements for rail transit agency and State Safety Oversight Agency personnel and contractors
 - Some bus transit agencies may participate in the voluntary bus curriculum established in the PTSCTP regulation

Requirements for a Comprehensive Safety Training Program

49 CFR Part 673 requires transit agencies to establish and implement a comprehensive safety training program for all agency employees and contractors directly responsible for safety in the transit system

This training program must include refresher training, as necessary



For Section 5307 recipients that serve a large UZA, the Bipartisan Infrastructure Law:

- Adds maintenance personnel as personnel that must participate in the safety training program
- Requires maintenance personnel, operations personnel, and personnel directly responsible for safety complete de-escalation training

Who does the comprehensive safety training program apply to?

Applies to transit agency employees and contractors designated by the agency as **directly responsible for safety**

- Part 673 does not specify which individuals at a transit agency are directly responsible for safety
- It is up to the transit agency to identify these individuals
 - For Section 5307 recipients that serve large UZAs, this must include maintenance employees
- For example - employees and contractors who work as part of the agency's safety function, such as safety officers and analysts, and operations and maintenance functions, such as managers, supervisors, and front-line employees



Refresher Training

- Transit agencies must establish a comprehensive safety training program that includes refresher training, as appropriate
- Refresher training helps ensure employees and contractors are current with the agency's safety practices and procedures

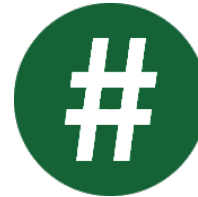

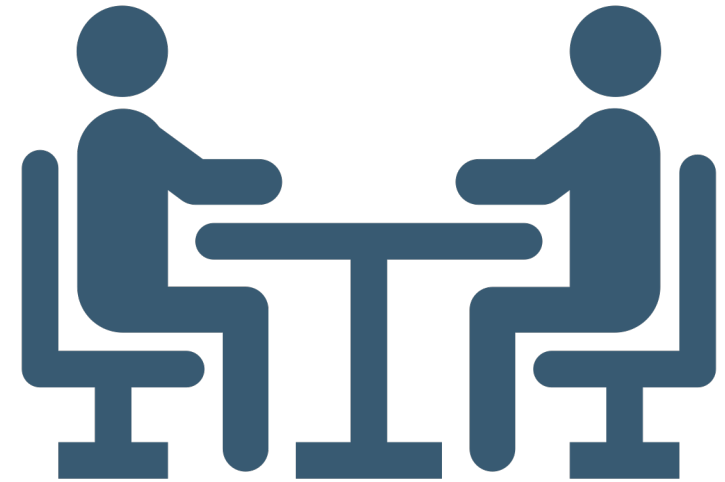
