Message from the Associate Administrator

Dear Transit Colleagues:

As we approach the end of Federal Fiscal Year (FY) 2023, I want to reflect on the safety goal of using data to inform safety decisions and ask how FTA can assist you in meeting your goals. FTA is here to work with you to create safer transit systems across America, whether it is through [webinars](#) or the [Public Transportation Agency Safety Plans \(PTASP\) Technical Assistance Center \(TAC\)](#).

FTA published the [Safety Training Schedule for FY 2024](#) earlier this month. Safety training plays a vital role in creating safer transit systems across America and the new training offers additional face-to-face deliveries. I encourage you

to review the training schedule and plan accordingly for any training requirements you may have under the [Public Transportation Safety Certification Training Program regulation](#).

In addition, FTA issued a [safety advisory](#) recommending that transit agencies consider mitigation strategies to reduce the likelihood and severity of bus collisions with pedestrians, bicyclists, and people using other micromobility devices. Learn more about the safety advisory on page 6.

Looking ahead to the fall, mark your calendars for the [2023 FTA Joint State Safety Oversight and Rail Transit Agency](#) Workshop in St. Louis, MO from Tuesday, November 14, 2023 to Thursday, November 16, 2023! This year, the first day of the workshop will be in-person and is intended for State Safety Oversight Agencies and their approved contractors only. Registration is open on the workshop [webpage](#).

Lastly, FTA recognizes [Rail Safety Week](#). In addition to highlighting the Stop Track Tragedies campaign, this year's Rail Safety Week resources include new youth materials developed as part of FTA's cooperative agreement with Operation Lifesaver Inc. FTA published a dedicated [rail grade crossing safety webpage](#) and will host a [webinar](#). [FTA Deputy Administrator Veronica Vanterpool](#) and I recorded video messages supporting this mission. While emphasizing the importance of rail safety, I want to stress that transit safety is a year-round priority.

Fiscal Year 2024 Transportation Safety Institute (TSI) Safety Training Available

These courses also support FTA grantees subject to the [Public Transportation Safety Certification Training Program \(PTSCTP\) regulation](#) with initial training and refresher training requirements. The FY24 safety training schedule offers some additional face-to-face deliveries.

FTA Awards Research Grant to the USF to Support Worker Safety

FTA awarded a research grant to the University of South Florida (USF) to identify safety risks for transit workers and riders and to determine the most effective strategies to minimize the risk. USF brings decades of experience working with transit agencies, transit workers' unions and other industry partners around transit safety and operations. The grant is part of the first phase of FTA's [Transit Worker and Rider Safety Best Practices](#) initiative. The initiative will better inform FTA's efforts in developing public transportation safety measures in the light of many reports of violence towards transit workers. The first phase is expected to take approximately 18 months to complete. A major deliverable for this phase will be a best practice report on transit assault mitigation strategies and countermeasures.

After identifying best practices, a second research phase will establish pilot demonstration projects with transit agencies to validate and promote the mitigation strategies using a [Safe System Approach](#) to reduce safety hazards affecting transit workers and riders. FTA has initiated multiple actions to both identify potential transit worker safety mitigations, safety standards, and to prevent operator assault. These efforts include proposed rules to increase transit safety and operator safety, soliciting public input on improving safety for transit workers, convening stakeholders to discuss and test concepts for redesigning bus compartments for operator safety, and funding research on the impact of using bus automation to improve transit safety.

Available FTA Resources in Support of Rail Safety Week September 18 – 24



[Rail Safety Week](#) is an annual observance event spearheaded by [Operation Lifesaver, Inc. \(OLI\)](#) and rail safety partners across the U.S., Canada and Mexico. This event aims to raise awareness on ways to *Stop Track Tragedies*. Rail Safety Week is September 18–24, 2023.

In support of Rail Safety Week, FTA published a dedicated [Rail Grade Crossing Safety webpage](#) with links to safety bulletins, safety advisories, Transit Advisory for Safety Committee (TRACS) reports and other transit resources. In addition, [FTA Deputy Administrator Veronica Vanterpool](#) and [Associate Administrator Joe DeLorenzo](#) supported Rail Safety Week by filming video messages that stress rail safety. Lastly, OLI has created new materials to help promote rail safety during Rail Safety Week and beyond. This includes new [resource materials](#) focused on youth and a [new rail transit safety pledge](#).

FTA will host a webinar discussing transit rail grade crossing safety from operational and public education and outreach perspectives. FTA will provide an overview and the Center for Urban Transportation Research and MxV Rail will highlight research on engineering aspects related to rail grade crossing safety, as featured in the FTA Standards Development Program [Rail Transit Roadway and Pedestrian Grade Crossing Exploratory Report](#), and discuss research results. The webinar also will feature guest speakers from TriMet who will speak about their experiences with rail grade crossings and the non-profit, OLI, who will discuss safety education and outreach to transit riders and available transit agency resources. The webinar recording and presentation will be available soon.



FTA Issues Safety Advisory on Bus-to-Person Collisions

On September 19, 2023 FTA issued [Safety Advisory 23-1: Bus-to-Person Collisions](#) in the [Federal Register](#) to recommend that transit agencies consider mitigation strategies to reduce the likelihood and severity of bus collisions with pedestrians, bicyclists and those using other micromobility devices.

Data from the National Transit Database shows that bus-to-person collisions remain a top safety concern accounting for 15 percent of transit fatalities from 2008 to 2021, with left turns as a predominant risk focus area. FTA Safety Advisory 23-1 recommends that transit agencies identify specific hazards that may cause or contribute to bus-to-person collisions, assess the safety risks and implement mitigations to reduce the likelihood and severity of those collisions.

On FTA's website, you can find fact sheets, guidance and training available for [transit providers](#) on identifying safety hazards, completing a safety risk assessment and developing mitigations. FTA also has a dedicated [bus-to-person collision webpage](#) available with additional information. FTA will host a [webinar](#) on Thursday, October 5, 2023 at 2 p.m. ET to review key elements from the Safety Advisory, share resources available to transit agencies with safety risk assessments and mitigation implementation about bus-to-person collisions and will feature a transit agency guest speaker who will share their experience with addressing risks associated with bus-to-person collisions, including mitigation strategies and lessons learned.

FTA Employee Spotlight: Valerie Beck



Valerie Beck

Division Chief, Safety Assurance and Risk Management, Office of System Safety, Office of Transit Safety and Oversight, FTA

How would you explain your job to someone you have never met? I am the Chief of the Safety Assurance and Risk Management Division in the Office of Transit Safety and Oversight. The division is responsible for monitoring industry safety performance, identifying safety hazards and mitigating safety risks to improve transit safety.

What were you doing prior to this role? Prior to joining FTA, I spent nine years as an Enforcement and Litigation Attorney at the Federal Motor Carrier Safety Administration (FMCSA), where I worked on a broad array of safety enforcement and compliance programs, including FMCSA's data-based risk prioritization system and its hours of service regulations. I also worked in FMCSA's Office of Policy and its Office of Enforcement and Compliance. Prior to that, I worked as a litigator for a large law firm in New York for six years.

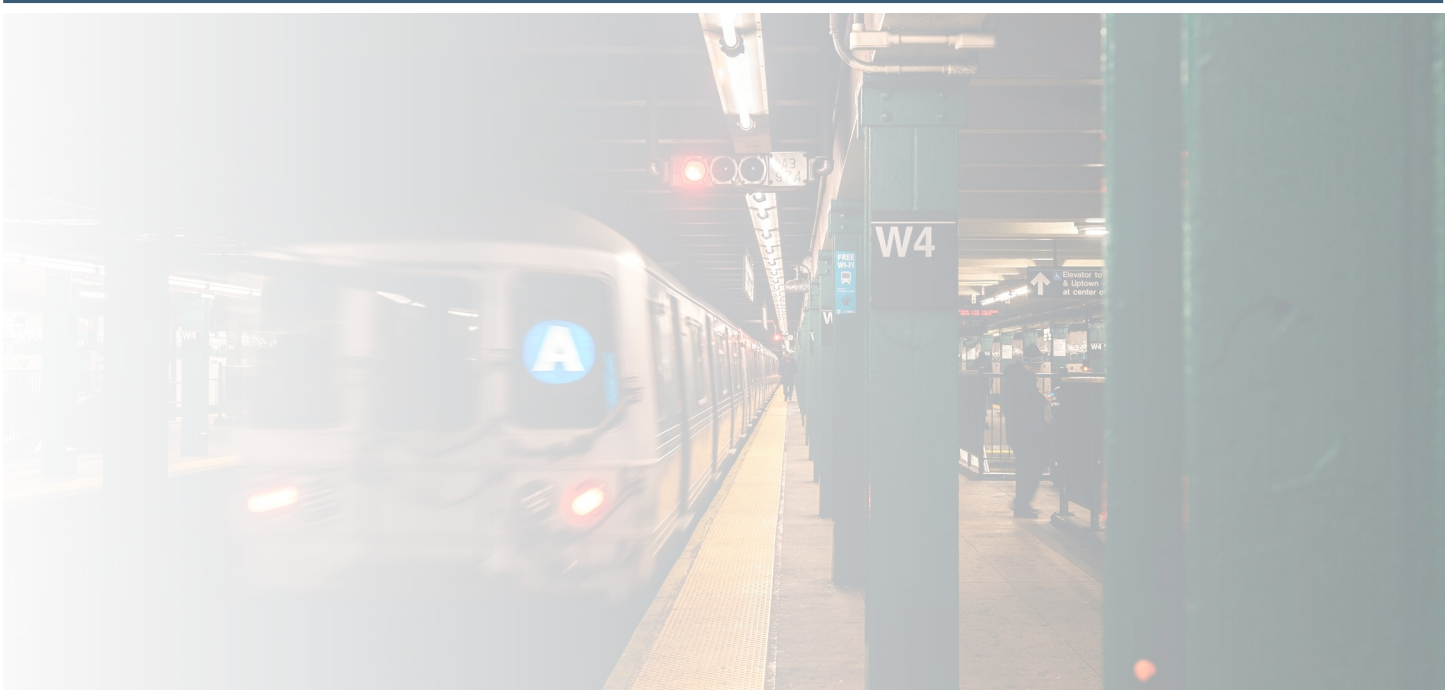
What is your favorite transit system in the U.S.? I appreciate how New York City transit allows you to do absolutely everything without a car. I especially like the ferry system. It is an incredibly extensive and accessible transit system.

What was your first time using public transit like? I have many early memories of taking the train into New York with my family. We would often take the Port Authority Trans-Hudson train to the World Trade Center to meet my dad for dinner.

What people or experiences have shaped you? There are so many! Starting my career in the federal government with FMCSA was a wonderful experience in working for an extremely mission driven organization. The culture at FMCSA is entirely focused on safety. I worked on FMCSA's initiative to make bus and truck safety data transparent to the public and saw firsthand how that program transformed the safety culture in the industry.

What does your perfect breakfast look like? A good egg sandwich, fresh fruit and, of course, lots of coffee.

What do you do to unwind after a hard day? I have a four-year-old and an eight-year-old, so generally, there is no unwinding! When I have time to myself, I enjoy music, exercise and yoga.
