## Message from the Associate Administrator

Dear Transit Colleagues:

With the start of March Madness college basketball upon us, spring is here and with the warmer weather, comes the end of the first quarter of 2024. I want to take a moment to look at what FTA has accomplished so far and preview what is coming up for the rest of the year.

FTA <u>issued</u> a Notice of Proposed Rulemaking (NPRM) for public comment on proposed minimum safety standards for Rail Transit Roadway Worker Protection (RWP). The <u>safety of our transit workers</u> is of paramount importance, and unsafe practices and conditions place rail transit workers at

risk of being killed or seriously injured while performing work on the railway. The National Transportation Safety Board and FTA's Transit Advisory Committee for Safety both have recommended regulatory action to address rail transit worker railway safety. With this proposed rule, FTA would establish minimum safety standards to prevent safety events for transit workers who may access the railway in the performance of work. The proposed rule would be FTA's first standardsbased regulation. The NPRM will be open for a 60-day comment period. I encourage you to <u>register</u> as early as possible as each workshop is limited to 50 people. A waitlist will be provided and, if there is a high demand, FTA may offer more virtual workshops at a later date.

The transit industry celebrated National Transit Employee Appreciation Day on Monday, March 18, and I want to thank transit employees who help keep American public transit systems operating safely. Transit workers provide a crucial service as transit connects communities and gets riders to their destinations safely every day. FTA is committed to keeping transit workers safe so they can continue their important work.

### One Year of the National Roadway Safety Strategy Call to Action Campaign



One year after the launch of the <u>National Roadway Safety Strategy (NRSS)</u> <u>Call to</u> <u>Action campaign</u>, many transit agencies are embracing the goals of the NRSS by implementing significant measures that improve the safety of their transit vehicles and their local street networks to help reduce roadway fatalities to zero. Below are updates from a few transit agencies demonstrating an ongoing commitment to the NRSS.

The Delaware Transit Corporation identified "Safer Vehicles" as a key goal of its NRSS commitment, and the agency is using a vehicle collision avoidance system on its buses to help prevent crashes and create safer vehicles throughout Delaware. To take action, the Delaware Transit Corporation began collecting and analyzing data on a weekly basis about driver performance in categories like collision

avoidance, fleet safety, employee safety and training. The agency is finding this strategy highly successful for driver training and education, both in terms of recognizing drivers with good safety ratings while focusing training on areas of improvement, such as correcting aggressive driving behaviors, especially speeding and lane discipline. By using data, the Delaware Transit Corporation can continue enhancing safe and efficient transit operations.

Denver's Regional Transportation District's (RTD) key NRSS goal is partners in safety, and the agency's top two goals (of seven outlined in its commitment) focus on identifying the most frequent, risky behaviors and reducing them by five percent by the end of 2023. Using event recorder data, RTD identified "unsafe following," "speeding" and "incomplete stops at stop signs" as the most frequent, risky behaviors. After implementing safety training measures, the agency saw reductions in two of the most frequent, risky behaviors (unsafe following and speeding) by 5 percent by the end of 2023. The third (incomplete stops at stop signs) is still in progress. RTD also required safety training for revenue and non-revenue vehicle operators and implemented a public safety outreach campaign among the many goals of its NRSS commitment.

San Francisco Municipal Transportation Agency's (SFMTA) top goals for the NRSS focus on "Safer Roads" and "Safer Speeds." Through its Quick-Build Program, SFMTA is focusing on completing projects in its High Injury Network (approximately 12 percent of streets where more than 68 percent of severe and fatal traffic injuries occur), adding continental crosswalks, advanced limit lines, daylighting, traffic signal retiming and turn calming intersections. In addition, SFMTA committed annually to completing 100 traffic calming devices such as speed humps, speed tables or raised crosswalks. Lastly, legislation passed in October 2023 included San Francisco in a Speed Camera Pilot program and SFMTA will begin building out this program in 2025.

The City of Phoenix Public Transit Department is advancing projects related to the NRSS goals of "Safer People," "Safer Roads," "Safer Vehicles" and "Safer Speeds," by leveraging partnerships with other city departments and updating the current bus fleet. Actions taken include installing LED lighted exterior mirrors on nearly 50 percent of its bus fleet, and new buses will have these mirrors factory installed. The lighting feature alerts pedestrians of bus proximity, particularly in and around intersections. The bus fleets also have safety measures such as a drive cam, which monitors operator driving habits and provides an opportunity to instill corrective actions. In addition, the Phoenix Street Transportation Department oversees Phoenix's Vision Zero Community Advisory Committee, which consists of 11 members appointed by the Mayor and City Council. It provides recommendations and feedback on the implementation of the Vision Zero Road Safety Action Plan.



# FTA Publishes Proposed Rule to Strengthen Rail Transit Roadway Worker Protection

On March 25, 2024, FTA <u>issued</u> a Notice of Proposed Rulemaking (NPRM) for public comment on proposed minimum safety standards for Rail Transit Roadway Worker Protection (RWP). The RWP NPRM will be open for a 60-day public comment period, closing on May 24, 2024. Submit your comments <u>here</u>.

The <u>safety of our transit workers</u> is of paramount importance, and unsafe practices and conditions place rail transit workers at risk of being killed or seriously injured while performing work on the roadway. The National Transportation Safety Board (NTSB) and FTA's Transit Advisory Committee for Safety (TRACS) both have recommended regulatory action addressing rail transit roadway worker safety.

According to data collected by the FTA, railway worker accidents have caused more transit worker fatalities than any other safety event in the past 30 years. As reported in the National Transit Database



(NTD) between January 1, 2008, and October 31, 2022, 22 workers were killed and 120 workers were seriously injured in accidents on the railway, equating to approximately 1.5 workers killed and just over eight workers seriously injured per year.

With this NPRM, FTA proposes establishing minimum safety standards to prevent safety events for transit workers who may access the railway in the performance of work. The proposed rule would apply to Rail Transit Agencies (RTA) in the State Safety Oversight (SSO) program, SSO Agencies (SSOAs) and rail transit workers who access the roadway to perform work.

The proposed rule would:


- Require each RTA to adopt and implement an RWP program to improve transit worker safety consistent with Federal and state safety requirements and approved by their SSOA.
- Establish minimum RWP program elements, including job safety briefings, lone worker protection and good faith safety challenges.
- Require each RTA to document its RWP program in a manual that includes a track access guide.
- Implement an RWP training program that addresses all transit workers responsible for on-track safety.

#### Fiscal Year 2024 Transportation Safety Institute (TSI) Safety Training Available

Registration is open for the Transportation Safety Institute's (TSI) Fiscal Year (FY) 2024 safety training courses for transit personnel. These courses also support FTA grantees subject to the <u>Public Transportation Safety Certification</u> <u>Training Program (PTSCTP) regulation</u> with initial training and refresher training requirements. The FY24 safety training schedule offers some additional face-to -face deliveries.



- <u>FTA-Sponsored Training Courses</u> provides information on FTA-sponsored FY24 training delivered by the TSI.
- <u>TSI Course Schedule</u> includes TSI safety training courses for transit personnel to support FTA grantees subject to the <u>PTSCTP</u> regulation with initial training and refresher training requirements. In addition to PTSCTP bus and rail courses, training includes courses for bus, rail, general transit safety and transit crime prevention and emergency management. - <u>Enhanced Transit Safety and Crime Prevention Initiative Related Training</u> offers virtual Assault Awareness and Prevention (AAP) and Violence in the Transit Workplace (VTW) courses provided by the National Transit Institute (NTI). The AAP and VTW courses support the FTA Enhanced Transit Safety and Crime Prevention Initiative. Transit agencies can also use the AAP course to fulfill the new <u>Bipartisan Infrastructure Law requirement</u> for de-escalation training.
