# FTA Publishes New Technical Resources on Assaults on Transit Worker Data Reporting

In May, FTA published new resources for transit agencies to clarify the new Bipartisan Infrastructure Law (BIL) requirements for expanded reporting of assaults on transit workers to help transit agencies understand the difference between major and non-major events, distinguish between physical and non-physical assaults and to understand the details of how to report transit worker assault data to the National Transit Database. #### Fiscal Year 2024 Transportation Safety Institute (TSI) Safety Training Available

Registration is open for the Transportation Safety Institute's (TSI) Fiscal Year (FY) 2024 safety training courses for transit personnel. These courses also support FTA grantees subject to the <a href="Public Transportation Safety Certification Training Program (PTSCTP) regulation</a> with initial training and recertification training requirements. The FY24 safety training schedule offers some additional face-to-face deliveries.

In addition to PTSCTP bus and rail courses, training includes courses for bus, rail, general transit safety and transit crime prevention and emergency management. - Enhanced Transit Safety and Crime Prevention Initiative Related Training offers virtual Assault Awareness and Prevention (AAP) and Violence in the Transit Workplace (VTW) courses provided by the National Transit Institute (NTI). The AAP and VTW courses support the FTA Enhanced Transit Safety and Crime Prevention Initiative. Transit agencies can also use the AAP course to fulfill the new <u>Bipartisan Infrastructure Law requirement</u> for de-escalation training. 
# 2024 Safety Management System (SMS) in Practice: Advancing Safety Risk Management and Safety Assurance

This year, FTA hosted four SMS in Practice: Advancing Safety Risk Management and Safety Assurance workshops. The series spotlighted common challenges identified during FTA Technical Assistance Center inquiries, audits and Agency Safety Plan (ASP) reviews. The workshop series concluded this month and asked participants to engage in group discussions and scenario-based exercises to obtain a deeper understanding of the processes and apply new skills and lessons learned to improve safety at their agencies. FTA provided these workshops for transit agency safety department personnel, State Safety Oversight Agency managers and staff and rail and bus transit operations and maintenance managers who oversee agency safety performance.

#### FTA Spotlights Mental Health Support in the Transit Industry



In May, as part of Mental Health Awareness Month, FTA hosted a <u>webinar</u> on suicide prevention and mental health crisis intervention in the transit industry. Guest speakers from the Substance Abuse and Mental Health Services Administration, San Francisco Suicide Prevention, Bay Area Rapid Transit and Utah Transit Authority shared available resources, experiences and lessons learned from successful interventions.

During the webinar speakers provided an overview of the suicide and crisis lifeline 988 system, de-escalation tactics for individuals experiencing mental health crises and shared personal experiences using the resources discussed to assist transit passengers through their mental health crises.

Mental health is a significant issue that impacts the transit industry and frontline workers. In recognition of this, we have updated FTA's <u>mental health website</u> with new toolkits, handouts, articles and more. FTA encourages you to share these online resources widely with the transit agencies in your network.

#### NOW AVAILABLE: Fiscal Year (FY) 2024 Transit Security Grant Program

On April 16, 2024 the Federal Emergency Management Agency (FEMA) announced the Notice of Funding Opportunity (NOFO) for the FY24 Transit Security Grant Program with \$83.7 million available to transit agencies. The grant program provides funding to eligible public transportation systems to provide protection from terrorism and increase infrastructure resilience. The FY24 grant specifically focuses on enhancing cybersecurity and the protection of soft targets and crowded places. Visit the FEMA website to learn more about the funding opportunity.

What is your favorite moment of your professional career so far? Being here at FTA; after working over 29 years in the engineering and transportation industry.


