### Message from the Associate Administrator

Dear Transit Colleagues:

We continue to make progress on our safety regulatory agenda. On August 14, 2024, FTA <u>published</u> final updates to the <u>Public Transportation Safety</u> <u>Certification Training Program (PTSCTP) regulation (49 CFR part 672)</u>. The final rule streamlines communication and administrative processes, clarifies voluntary participation and recertification training requirements and responds to comments received on the PTSCTP Notice of Proposed Rulemaking (NPRM). The final rule maintains the existing minimum training requirements for State Safety Oversight Agency (SSOA) personnel who conduct reviews, inspections,

examinations and other safety oversight activities of public transportation systems and transit agency employees and contractors directly responsible for the safety oversight of a rail fixed guideway public transportation system. FTA will host a webinar to provide more information about PTSCTP updates and will announce the date soon.

The final training rule follows the April 2024 publication of the <u>Public Transportation Agency Safety Plans</u> (<u>PTASP</u>) final rule and <u>National Transportation Safety Plan</u>, furthering the Bipartisan Infrastructure Law requirements to make transit safer for passengers and workers nationwide. FTA hosted a webinar on August 13, 2024 and you can view the recording and presentation <u>here</u>.

As we prepare for the upcoming school year, educating our children and families about transit safety is important, particularly around rail grade crossings. Operation Lifesaver Inc., (OLI) has age-targeted resources for children to encourage transit safety best practices. For agencies, OLI opened the application period for its competitive Rail Transit Safety Education Grants offering \$190,000 in funding for transit agencies and government entities that provide transit service to conduct rail transit safety education and public awareness initiatives. Submit applications by September 1, 2024.

In late June, the Transit Advisory Committee for Safety (TRACS) met to continue defining and providing transit safety information, advice and recommendations to the U.S. Transportation Secretary and FTA Administrator. FTA published three TRACS reports on advancing rider and worker safety, reducing bus collisions and cyber and data security. View their recommendations on the <u>TRACS Reports webpage</u>.

Your support of our mutual safety mission is critical to our collective success. Thank you for all you do to help your agencies ensure that workers and riders alike can get to and from their destinations safely.

#### **FTA at Recent Transit Industry Events**

In July, FTA's Stewart Mader, Senior Program Analyst for Safety Policy, provided an update on the agency's Public Transportation Agency Safety Plans (PTASP) Final Rule, the National Public Transportation Safety Plan, assaults against transit workers and the FTA regulatory agenda to the State & Tribal Public Transportation Partnerships Conference in Fort Worth, Texas.

At the 2024 Capital Project Management (CPM) Workshop in Washington, D.C., Stewart Mader provided updates on project management oversight, statutes, regulations, policies, program requirements, guidance, best practices, lessons learned and other related issues.

Earlier this month, FTA's Ivey Glendon, Acting Division
Chief for the Office of System Safety, and Stewart
Mader presented at the 2024 Community
Transportation Association of America (CTAA) Sun

Conference in Alexandria, Virginia. They provided updates on bus safety, assaults against transit workers, bus collision analysis and updates, the proposed General Directive 24-1: Required Actions Regarding Assaults on Transit Workers, and updates to the PTASP Final Rule and National Public Transportation Safety Plan.

### **FTA Publishes Updates to its Safety Certification Training Regulation**

FTA is actively working with the transit industry to provide safety training that is responsive to the industry's needs. The <a href="Public Transportation Safety Certification Training Program">Program</a> (PTSCTP) regulation (49 CFR part 672), originally published in 2018, sets forth Federal training requirements for rail transit agency personnel who are directly responsible for <a href="Safety oversight">Safety</a> oversight of rail transit systems and State Safety Oversight Agency (SSOA) personnel who conduct safety reviews, inspections, examinations and other safety oversight activities of public transportation systems.

On August 14, 2024, FTA <u>published</u> final updates to the PTSCTP regulation. The final rule maintains a uniform safety training curriculum and minimum requirements for SSOAs and safety professionals in rail transit agencies. This final rule is part of the Biden-Harris Administration's continuous efforts and focus on keeping public transportation the safest mode of surface travel.

FTA reviewed comments received from the industry and included the following updates to the regulation:

- Requiring SSOAs and rail transit agencies to establish a point of contact for communication with FTA. The
  points of contact must provide semiannual reporting to FTA regarding participants status and their agencydefined recertification training requirements.
- Clarifying voluntary participation in the PTSCTP, including that voluntary participants are not required to complete recertification requirements to maintain their voluntary certification.
- Adding a recertification element defined by FTA.
- Removing Appendix A to allow flexibility in PTSCTP curriculum revision.
- Updating definitions to clarify existing requirements and adding definitions to provide consistency with other FTA programs and rulemakings.

Additionally, FTA sought industry input on whether mandatory PTSCTP participation should extend to bus transit agencies and personnel and decided that it would not expand its applicability at this time.

While the updates are primarily administrative, they will enable FTA to effectively monitor compliance with the regulation and improve existing processes to ease the burden on transit agencies and SSOAs to coordinate the training program requirements.

The original regulation included minimum requirements to enhance the technical proficiency of those who conduct safety audits and examinations and those directly responsible for safety oversight. Since the PTSCTP regulation took effect, more than 1,400 designated safety personnel have completed training requirements, contributing to U.S. DOT's broader effort to make transportation safer for all.

### FTA Drug and Alcohol Regulation Updates: July 2024

#### **Post-Accident Timing**

Employers must mitigate inefficiencies and delays in the post-accident decision-making and testing processes so post-accident testing can be completed as soon as practicable. If a required post-accident alcohol test is not administered within two hours following an FTA-defined accident, 49 CFR 655.44(a)(2)(ii) requires employers to prepare and maintain a record stating the reasons the test was not promptly administered. If the post-accident alcohol test is not administered within eight hours, employers must cease attempts to complete the test and maintain a record of why the test was not completed. The two-hour and eight-hour windows are calculated from the time of the accident to the time of the alcohol test, as recorded on the Alcohol Testing Form (ATF). Read the rest of the article here.

### Fiscal Year 2024 Transportation Safety Institute (TSI) Safety Training Available

Registration is open for the Transportation Safety Institute's (TSI) Fiscal Year (FY) 2024 safety training courses for transit personnel. These courses also support FTA grantees subject to the <a href="Public Transportation Safety Certification Training Program">Public Transportation Safety Certification Training Program</a> (PTSCTP) regulation with initial training and recertification training requirements. The FY24 safety training schedule offers some additional face-to-face deliveries.

In addition to PTSCTP bus and rail courses, training includes courses for bus, rail, general transit safety and transit crime prevention and emergency management. The AAP and VTW courses support the FTA Enhanced Transit Safety and Crime Prevention Initiative. Transit agencies can also use the AAP course to fulfill the new <u>Bipartisan Infrastructure Law requirement</u> for de-escalation training. ### FTA Celebrates 60 Years of Improving America Through Public Transit

After 60 years of improving American communities through public transportation, the <u>FTA reflects</u> on the history of the Federal transit program.

After witnessing the nation's expansive investment in national highways and road networks during the 1950s, and the corresponding disinvestment and decline in public transit ridership, President John F. Kennedy proposed to Congress in 1962 a Federal program to invest in transit. Two years later, President Lyndon Johnson signed the legislation creating the federal transit program. For the first time, the federal government provided financial and technical assistance to support transit bus and rail systems across the U.S. In 1964, The Urban Mass Transportation Administration (UMTA) was created to manage the transit program.

This federal investment in public transportation initiated a steady recovery for transit systems across the country. The federal support leveraged local resources to first stabilize transit systems that were on the brink of collapse in the '60s and early '70s, then rebuilt and expanded service, creating a resurgence in transit.

UMTA was renamed the Federal Transit Administration in 1991 to reflect its inclusion of suburban and rural areas and to ensure mobility for all Americans. Today, FTA supports more than 3,500 transit agencies and State Departments of Transportation nationwide to ensure everyone can fully participate in their communities, riding to work, to the doctor, to shop, and to see family and friends.

Fast forward to 2021, the Bipartisan Infrastructure Law, passed by Congress and signed by President Biden, marks the

largest transit investment in American history – \$108 billion over five years – helping transit providers expand service to reach more people, make communities safer, improve the rider experience and reduce the greenhouse gas emissions responsible for climate change.

When UMTA was established, it received \$375 million in federal funds to support transit capital projects. Today, we manage a budget of \$21 billion.

Together, we can make FTA better than ever, supporting programs that modernize transit, combat the climate crisis through low- and no-emission buses, improve access for people with disabilities, replace aging railcars, expand tribal transit, advance research and innovation, promote civil rights, and provide safety oversight.

### NOW AVAILABLE: Operation Lifesaver, Inc. Rail Transit Safety Education Grants

In June 2024, FTA began a new cooperative agreement with Operation Lifesaver, Inc. (OLI) to provide technical assistance to state operation lifesaver programs, transit agencies and the general public regarding safety best practices to prevent fatalities and injuries at and around transit rail grade crossings. On July 1, 2024, OLI announced that the application period is open for its competitive Rail Transit Safety Education Grants. The grants offer a total of \$190,000 in funding for transit agencies and government entities that provide transit service to conduct rail transit safety education and public awareness initiatives. ### **USDOT Recognizes World Day Against Trafficking in Persons**

On July 30, 2024, the U.S. DOT recognized World Day Against Trafficking in Persons and hosted a Building Effective Public Awareness & Outreach Efforts for the Transportation Industry webinar alongside the U.S. Department of Health and Human Services. Expert panelists shared best practices for building effective public awareness and outreach efforts for the transportation industry that are trauma-informed, person-centered, culturally responsive, and data-driven. Panelists also shared examples from various federally funded multimodal public awareness campaigns on human trafficking and discussed lessons learned.

Every year, millions of men, women, and children are held against their will and trafficked into forced labor and commercial sex. Human traffickers exploit roadways, railways, waterways, and airways in urban, rural, and Tribal communities across the United States to recruit and transport their victims. DOT's "Combating Human Trafficking in the Transportation Sector Awareness Training" for transportation personnel underscores the intersection of human trafficking and transportation, provides general and transportation-specific indicators of human trafficking, and how to report a tip.
