

## 2026 NTD Safety & Security Quick Reference Guide – Non-Rail Mode Reporting

**Reportable Event:** A safety or security event occurring on transit right-of-way or infrastructure, at a transit revenue facility, at a maintenance facility, during a transit related maintenance activity, or involving a transit revenue vehicle. *Excluded from this event-reporting requirement are: events that occur off transit property where affected persons, vehicles, or objects come to rest on transit property after the event, OSHA events in administrative buildings, deaths that are a result of illness or other natural causes, other events (assault, robbery, non-transit vehicle collisions, etc.) occurring at bus stops or shelters that are not on transit-owned property (unless boarding/alighting at the time), collisions that occur while traveling to or from a transit-related maintenance activity, collisions involving a supervisor car, or other transit service vehicle operating on public roads.*

<p><b>MAJOR THRESHOLDS</b></p> <hr/> <p>An event meeting the reportable event definition AND meeting <u>one or more</u> of the following reporting thresholds:</p> <ul style="list-style-type: none"> <li>• A fatality confirmed within 30 days (including suicide)</li> <li>• An injury requiring transport away from the scene for medical attention for one or more persons (partial exception in the case of Other Safety Events)</li> <li>• Estimated property damage equal to or exceeding \$25,000</li> <li>• An evacuation for life safety reasons</li> <li>• Collisions involving transit roadway revenue vehicles that require towing away of a transit roadway vehicle or other non-transit roadway vehicle due to disabling damage.</li> </ul> <p><i>Reports are due within 30 days of the date of the event.</i></p>	<p><b>NON-MAJOR THRESHOLDS</b></p> <hr/> <p>Assault on a transit worker with no injury. Other Safety single-injury incidents meeting the reportable event definition that <b>ARE NOT</b> a result of a collision, derailment, evacuation, major security event, hazmat spill, Act of God; or non-major fire.</p> <p><b>Non-Major Assaults on Transit Workers:</b></p> <ul style="list-style-type: none"> <li>• Non-injury (no transport)</li> <li>• Intent to endanger the safety of any individual</li> <li>• With reckless disregard for the safety of human life.</li> </ul> <p><b>Other Safety Incidents:</b></p> <ul style="list-style-type: none"> <li>• <b>Single injury</b> event requiring transport away from the scene for medical attention.</li> </ul> <p><b>Fire:</b></p> <ul style="list-style-type: none"> <li>• Required suppression but <b>does not</b> meet a major incident reporting threshold.</li> </ul> <p><i>Reports due by the end of the following month</i></p>

<p><b>Safety Events</b></p> <ul style="list-style-type: none"> <li>• <b>Collision</b> (including suicide/attempted suicide/assault involving transit vehicle contact)</li> <li>• <b>Fire</b></li> <li>• <b>Hazardous material spill</b> (requires <i>specialized</i> clean-up)</li> <li>• <b>Acts of God</b> (nature)</li> <li>• <b>Other Safety Occurrences Not Otherwise Classified</b> (two injuries and/or another threshold) <ul style="list-style-type: none"> <li>○ Miscellaneous events that meet a threshold</li> </ul> </li> </ul> <p><b>System Security Events</b></p> <ul style="list-style-type: none"> <li>• Arson</li> <li>• Bomb threat/bombing</li> <li>• Burglary / Vandalism</li> <li>• Chemical/biological/radiological/nuclear release</li> <li>• Cyber security event</li> <li>• Hijacking</li> <li>• Sabotage</li> <li>• Suspicious package</li> <li>• Other security event (shots fired, projectiles, etc.)</li> </ul> <p><b>Personal Security Events</b></p> <ul style="list-style-type: none"> <li>• Assault (no transit vehicle contact)</li> <li>• Homicide (no transit vehicle contact)</li> <li>• Suicide or Attempted Suicide (no transit vehicle contact)</li> <li>• Robbery</li> <li>• Larceny/theft</li> <li>• Motor vehicle theft</li> <li>• Rape</li> <li>• Other personal security events (e.g., perpetrator tased)</li> </ul>	<p><b>Non-Major Assaults on Transit Workers</b></p> <p><i>Includes both Physical and Non-Physical Assaults</i></p> <ul style="list-style-type: none"> <li>• Threat of violence</li> <li>• Verbal assault/harassment</li> <li>• Spitting or striking</li> <li>• Interference with transit workers' duties</li> </ul> <p><b>Other Safety Incident</b></p> <p>Single Injury due to:</p> <ul style="list-style-type: none"> <li>• Slip/Trip</li> <li>• Fall <ul style="list-style-type: none"> <li>○ Including people making contact with a non-moving transit vehicle</li> <li>○ Excludes individuals injured at bus stops unless boarding or alighting a transit vehicle at the time of the event</li> </ul> </li> <li>• Injury to maintenance worker</li> <li>• Boarding/alighting</li> <li>• Abrupt or evasive transit vehicle maneuvers</li> <li>• Mobility device (e.g., wheelchair) securement issues</li> </ul> <p>Excludes individuals transported for mental health evaluation unrelated to a reportable event due to declarations of self-harm, solely for intoxication, drug overdose or exposure to the elements.</p> <p><b>Fire:</b></p> <ul style="list-style-type: none"> <li>• Required suppression but no major threshold is met. <ul style="list-style-type: none"> <li>○ Small fire on in transit station</li> <li>○ Small engine fire on transit vehicle</li> </ul> </li> </ul>
