KY ARRA PROJECT SELECTION/PROCEDURE

- Agency 3-year Capital Needs in current application
- January 12, 2009, State Highway Engineer
 - FHWA Headquarters Economic Recovery Bill Action
- January 15, 2009, FTA requested identified potential transit project
 - Ready to Go Projects/TIP-STIP
 - Ky submitted January 20, List of Projects
- January 23, 2009- Statewide Meeting
 - State requested Preliminary ARRA Projects
- January 26, 2009-State received 1st round of ARRA project requests



KY ARRA PROJECT SELECTION/PROCEDURE

- State compiled Project List started ranking and analyzing
- February 2009 call for final ARRA projects
 - Required ARRA projects to be included in coordination meeting and public hearings
 - Final notice mailed to transit agencies
- March 3, 2009 Deadline for ARRA Budgets
- State had final Ranking of Projects and compiled Program of Projects
- Met March 24, 2009 with Statewide Agencies
 - To discuss reporting, creation of jobs, contract

 - State Analyst ranked each proposed project numerically
 - Public Transit Ranked as a Group, numerically

REQUIRED CERTIFICATIONS

SECTION 1511: Secretary Prather has certified for all Highway and Transit projects that the infrastructure has received the full review and vetting required by law and that we accept responsibility that such investments are appropriate uses of taxpayer dollars and that the is provided on the Kentucky Statewide Transportation Improvement Program and is available to the public at [http://transportation.ky.gov/progmgmt/stip/stip06.htm] and linked to Recovery.gov.

SECTION 1201: Governor Beshear certified for all Transit and Highway projects that Commonwealth will maintain its effort with regard to State funding for the types of projects that are funded by amounts appropriated by ARRA. An estimate of State expenditures under ARRA “covered programs” was included as part of the Certification.

SECTION 1607: Governor Beshear certified for all Transit and Highway projects that all funds provided by ARRA to the Commonwealth of Kentucky or its agencies that the Commonwealth will request and use funds provided by ARRA and the funds will be used to create jobs and promote economic growth.

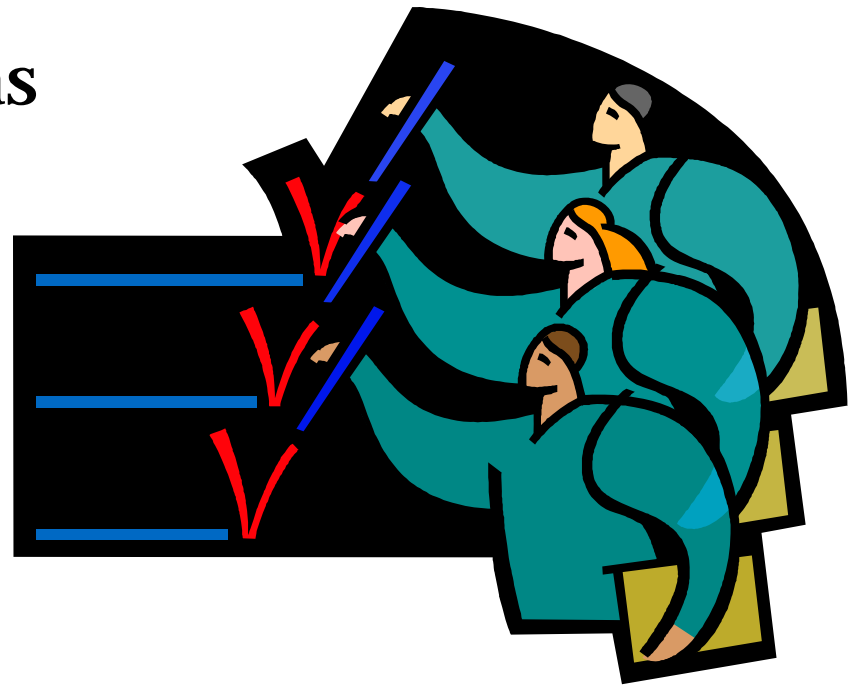
