



What Does Adoption of SMS Policy Mean?

Consistent with the methods and principles of SMS, FTA will give priority in our rulemaking, enforcement, oversight, and resources towards those issues that pose the highest risk to the safety of public transportation systems.

FTA's Safety Enforcement Authority

- Perform Compliance Assessments
 - Inspections
 - Investigations
 - Audits
 - Examinations
 - Testing
- Equipment, facilities, rolling stock, and operations



Compliance Assessments

- Requests for production of documents
- Request for confidential treatment of documents



Use or Withholding of Funds

- Establishes administrative process
- Triggers:
 - Pattern or practice of violation of regulation or directives
- Administrator may:
 - Require grantee to use funds to correct safety deficiencies
 - Withhold funds



Directives

General Directives

- Applicable to all (or subset of) grantees
- Effective upon notice in Federal Register
- Subject to public notice and comment

Special Directives

- Applicable to one or more named grantees
- Effective upon direct notice to grantee
- Establishes process for reconsideration



Advisories

Applicable to one or more grantees when an unsafe condition exists

- Recommends actions to identify and/or mitigate the unsafe condition
- Effective upon notice in the Federal Register
- Non-compliance may impact enforcement actions
- Establishes administrative process



National Public Transportation Safety Plan

- Defines purpose and contents
- Includes statutorily required components and other FTA proposed content
