# FTA Plans Expansion of SMS Pilot Program

To help the transit industry transition to a Safety Management System (SMS) approach to managing safety, the FTA is conducting an SMS Pilot Program at the Chicago Transit Authority (CTA) and is preparing to expand the program to up to three small to mid-size bus agencies.

The bus agencies' participation, which is slated to begin this summer, will bring valuable insight into the process for establishing an SMS at a smaller or bus-only agency to complement pilot work currently underway in Chicago. Through the pilot program, the FTA provides technical assistance to transit agencies on developing and operating an SMS, while transit agencies provide opportunities for the FTA to test the effectiveness of SMS tools in a diverse set of circumstances.

When an agency participates in an SMS pilot, the FTA provides onsite

training, guidance, technical assistance, and expertise, including templates and tools, that will help agencies complete the activities necessary to develop and implement an SMS. The agency has ongoing access to FTA's SMS Team throughout the pilot to support SMS development and implementation activities.

Transit agencies not involved in the pilot program benefit, too. The FTA will apply lessons learned and best practices identified through the program to develop guidance materials and technical assistance for the entire public transportation industry.

## **Deputy's Corner**

I'd like to share a few items for your awareness this month: a new safety advisory, a request for transit industry assistance in updating safety standards, and several upcoming FTA-sponsored training opportunities.

On May 16, the FTA issued Safety Advisory 16-2 to collect information from State Safety Oversight (SSO) Agencies regarding the condition and safety performance of contact rail (third rail) traction power electrification (TPE) systems at rail transit agencies within their

jurisdiction. Nationwide, 13 rail transit systems operate and maintain TPE systems to

Associate Administrator power trains that move millions of daily passengers in some of the nation's largest cities. In

recent months, FTA has investigated several safety events related to TPE system failures, including smoke incidents, explosions, fires, damage to railcar propulsion equipment, and exacerbated deterioration of poor track conditions. FTA requires that SSO Agencies submit the requested information within 90 days. For more information, contact Sam Shelton.

#### **Safety Standards**

The FTA recently worked with the Center for Urban Transportation Research to compile an inventory of safety standards and protocols. In accordance with the Fixing America's Surface Transportation (FAST) Act, the (cont. on pg. 3)




#### 2014 Drug and Alcohol MIS Results Show Increase in Positive Drug Test Rates

FTA's drug and alcohol testing results have been compiled from the 2014 Drug and Alcohol Management Information Systems (MIS) submissions. Positive rates for random testing increased to their highest level since 2003. Results also showed an increase in the number of specimens testing positive for Tetrahy-

drocannabinol (THC), the active ingredient in marijuana-a 40% increase in just a two-year period.

#### Positive Drug Rate – Random Testing






Drug test results from FTA grantees who receive Sections 5307, 5309, 5311 or 5339 funds

# **TSO Profile** Q&A with George Good, Jr., FTA Safety Investigator

George Good, Jr. joined the FTA in January 2015 as the agency's first safety investigator.



eorge ood, Jr. outside the Navy Yard Metro station at US DOT headquarters How would you explain your job to someone you've never met before? The Office of Transit Safety and Oversight's (TSO's) Accident Investigation Team investigates and reviews facts surrounding mass transit accidents and incidents. The primary goal of accident investigations is to identify the causal and contributing factors of an event and make sure corrective actions are taken to prevent a reoccurrence. We also help determine if events have implications at other transit agencies that would require the FTA to issue safety advisories or directives. We work closely with the transit industry and other DOT agencies to promote transit safety and develop recommended practices and procedures.

What were you doing prior to this role? I served 28 years with the State of Maryland. During that time I was a police officer, light rail operations supervisor and safety officer at the Maryland Transit Administration, and the Program Director for State Safety and Security Oversight at the Maryland Department of Transportation. I also served 33 years in the Air Force Reserve

in the C5 Galaxy maintenance, flight operations and safety career fields.

What is something you wish people knew about the FTA or TSO? The FTA works hard at making this a great place to work from the very start. The TSO team has great leaders and dedicated staff that really care about building a

best practice for safety in the transit industry. With that said, by creating a new function—or as our Associate Administrator likes to say, "building the fire truck on the way to the fire"—there are always things that might not work as planned. If that happens, our team is always ready to learn and work to make it better.

What were some of the challenges of being the FTA's first safety investigator? The accident investigation function was new to the FTA, State Safety Oversight (SSO) Agencies, and Rail Transit Agencies. As a result, it created some new growing pains and a learning curve for us all. It has also been a challenge starting from scratch with the drafting of standard operating practices and working to make them sync with the development and transition to new regulations. "Our team is always ready to learn and work to make it better. "

How do you collaborate with people outside of the FTA? How would you like to work with them in the future? We interact a lot with SSO Agencies and other transit safety and operations staff to request information and work together on investigations. We work with other DOT agencies such as the Federal Railroad Administration. They are closely matched to the rail operations we oversee. The DOT has a "One DOT" philosophy for working together in all administrations. We also work with the National Transportation Safety Board. They have the authority to allow us to become party to their investigations, and this type of teamwork is very beneficial to the investigations and actions taken to prevent reoccurrence.

FTA investigators would like become more familiar with the rail transit systems in the oversight program, their staff, and their SSO staff through site visits and tours of the transit systems. This would give States and rail transit agencies an opportunity to become more familiar with our staff as well.
