## **Regulatory Requirements**

#### 49 CFR Part 674.11(e)

At minimum, an SSO program must demonstrate that the employees and other personnel of the State safety oversight agency who are responsible for the oversight of rail fixed guideway public transportation systems are qualified to perform their functions, based on appropriate training, including substantial progress toward or completion of the Public Transportation Safety Certification Training Program.

  - Interim Safety Certification Training Provisions
    - Published in Federal Register on February 27,
       2015 with an Effective Date of May 28, 2015

# Interim Safety Certification Training Provisions

- Required Curriculum Over a Three Year Period
  - SMS Awareness (E-learning course via TSI's website; one hour)
  - Safety Assurance (Virtual classroom course; Delivered by TSI; two hours)
  - SMS Principles for Rail Transit (Traditional classroom course; delivered by TSI; 2.5 days)
  - Transit Rail Incident Investigation (Traditional classroom course; delivered by TSI; 4.5 days)
  - Effectively Managing Transit Emergencies (Traditional classroom course; delivered by TSI; 3.5 days)
  - Transit Rail System Safety (Traditional classroom course; delivered by TSI; 4.5 days)
