# Q & A Highlights

#### Question 1:

Our agency is in a unique situation. We were created by the State legislature in 2017 as a transit authority. However, we do not yet operate any bus service. The only service we currently offer is commuter vanpool, which we subsidize with Section 5307 funds. Since we do not yet operate bus service, do we still need to develop an ASP at this time?

#### **FTA Response:**

You indicated that you currently use Section 5307 funds for your vanpool service. Beginning July 20, 2020, to be eligible to receive Section 5307 funds for your transit service, you must have an approved ASP in place.

To qualify as a small public transportation provider, you must not operate any rail service and your nonrail modes must operate less than 101 non-rail vehicles in peak service. Fixed-route is counted as its own mode and non-fixed-route modes (such as vanpool) are counted individually. Per 49 CFR § 673.11(d), "A State must draft and certify a Public Transportation Agency Safety Plan on behalf of any small public transportation provider that is located in that State. A State is not required to draft a Public Transportation Agency Safety Plan for a small public transportation provider if that agency notifies the State that it will draft its own plan."

#### 2020 FTA PTASP Bus Workshops

When: Tuesday, January 28 or Wednesday, January 29, 2020

The <u>workshops</u> will focus on the requirements needed for agencies to comply with the PTASP rule and provide SMS implementation strategies. Additionally, the workshops will discuss how to begin creating ASPs, including the identification of key stakeholders to coordinate ASP development.

These one-day bus workshops are open to the staff and contractors of recipients or subrecipients of Urbanized Area Formula Grant Program funds who are responsible for developing or implementing an ASP, and State DOT staff that are responsible for drafting ASPs for the small public transportation providers within their States.

#### Question 2:

ABC Transit is not a recipient or subrecipient of Section 5307 funds, but they are a contractor for paratransit services for City Transit System. Does ABC Transit fall within the PTASP requirements?

#### **FTA Response:**

Contractors of direct recipients or subrecipients of Section 5307 Federal financial assistance are not required to develop a separate ASP per the requirements of Part 673.

Per the preamble of the PTASP rule, FTA defers to the recipient or subrecipient that contracts service to ensure that each of the requirements of Part 673 are met, including the identification of safety roles and responsibilities. The City Transit System could request that ABC Transit develop the entire ASP or elements of the ASP, but the City Transit System has the responsibility to ensure compliance with the regulation and certify compliance annually—not ABC Transit. Alternatively, City Transit System could develop the ASP on its own and ensure that ABC Transit follows it.

#### **Question 3:**

I'm a consultant doing work for a commuter rail provider. My client has previously prepared System Safety Program Plans. I would like to know if they must now comply with the PTASP rule that became effective this year. My client is a "tenant" railroad operating on tracks owned and controlled by its three "host" railroads. The operator receives Section 5307 grant funds but is also regulated by Federal Railroad Administration (FRA) given its "tenant" status. Must the operator complete an ASP by July 20,2020?

#### **FTA Response:**

No; per § 673.11(f), agencies that operate rail fixed guideway public transportation services regulated by the FRA are not required to develop ASPs for those modes of service.

The <u>PTASP Applicability infographic</u> on FTA's website illustrates which transit agencies need to create an ASP.
