General Applicability

Who needs to meet PTASP regulation requirements?

- The PTASP regulation applies to any <u>State</u> or <u>provider of public transportation</u> that receives Federal financial assistance under 49 U.S.C. Section 5307 (Urbanized Area Formula Program)
- The PTASP regulation also applies to any rail transit provider subject to the State Safety Oversight program, regardless of funding source



General Applicability

An organization must meet PTASP regulation requirements if it's a:

Transit Provider OR **State DOT** A provider of public A State with one or more transportation applicable small public transportation providers in the A recipient or An entity that State subrecipient of operates a rail a Section 5307 fixed guideway grant open on system under AND/ July 20, 2020 FTA's State OR Safety **Oversight** Program



General Applicability – Transit Providers

A provider of public transportation

- Public transportation is regular, continuing shared-ride surface transportation services that are open to the general public or a segment of the general public defined by age, disability, or low income
- Regardless of whether the service is provided directly, through a contractor, or other provider
- Excludes modes under the safety jurisdiction of the Federal Railroad Administration (FRA) or U.S. Coast Guard



General Applicability – Which modes?

Bus Modes

- Bus
- Bus Rapid Transit
- Commuter Bus
- Demand Response
- Demand Response Taxi
- Publico
- Trolley Bus
- Vanpool

Rail Modes

- Cable Car
- Heavy Rail
- Hybrid Rail
- Inclined Plane
- Light Rail
- Monorail/Automated Guideway
- Streetcar

Remember: Modes under the safety jurisdiction of FRA and U.S. Coast Guard—including commuter rail and ferries—don't count!



General Applicability – Transit Providers

A recipient or subrecipient of a Section 5307 grant open on July 20, 2020

- May be in combination with any other FTA grant
- As of July 20, 2020, transit providers must certify that they meet PTASP regulation requirements, if applicable, to be awarded FTA grant funds

Don't have an open Section 5307, but anticipate one in the near future? Consider beginning preparations to meet PTASP regulation requirements.



General Applicability – Transit Providers

- An entity that operates a rail fixed guideway system under FTA's State Safety Oversight Program
 - Regardless of current funding status
 - Even if not a Section 5307 recipient or subrecipient

General Applicability

What is the deadline to meet PTASP regulation requirements?

- States and transit providers must meet PTASP requirements no later than <u>July 20, 2020</u>
 - Includes requirements such as:
 - Developing an ASP
 - Implementing an ASP
 - Certifying compliance with the PTASP regulation



General Applicability

What is the penalty for not meeting PTASP regulation requirements?

- A transit operator would be ineligible to receive FTA grant funds until the operator satisfies the requirements of the regulation
- Failure to comply with the regulation may subject a grantee to a range of FTA enforcement options depending upon the circumstances



I receive Section 5307 funding from my State DOT. I don't get the money directly from FTA. Do the PTASP requirements apply to me?

Yes. As a subrecipient of Section 5307 funding, you need to meet PTASP requirements.



I'm a subrecipient and I receive Section 5307 funding from a large transit agency in my city. I don't get the money directly from FTA. Do the PTASP requirements apply to me?

Yes. As a subrecipient of Section 5307 funding, you need to meet PTASP requirements.



We previously used Section 5307 funding to purchase vehicles, but we won't have a Section 5307 grant in open status on July 20, 2020. Do we have to meet PTASP requirements by July 20, 2020?

No. If you won't have an open Section 5307 grant on July 20, 2020, you are not currently required to comply with PTASP requirements. However, in order to be eligible for future Section 5307 funding, you will need to meet PTASP requirements.

My transit agency only uses
Congestion Mitigation and Air
Quality Improvement (CMAQ)
program funds from the Federal
Highway Administration that are
flexed to 5307 funds. Do I need to
meet PTASP requirements?

No. CMAQ funds that are flexed to 5307 do not trigger PTASP regulation applicability.

Rail Transit Modes Frequently Asked Questions

My transit agency operates both rail and bus modes. Do I have to develop separate ASPs for my rail and bus modes?

No. Agencies that operate both rail and bus modes may develop one ASP to cover both rail and bus or may develop an individual ASP for their rail and bus modes.

How is a Small Public Transportation Provider different from other providers?



100 or fewer vehicles in revenue service during peak regular service <u>across all fixed</u> route modes



100 or fewer vehicles in revenue service during peak regular service in each non-fixed route mode



Does not operate rail transit



Small Public Transportation Providers


How are vehicle numbers calculated?

- It depends on how many vehicles operated in maximum service (VOMS) you have for each mode
 - VOMS: The revenue vehicle count during the peak season of the year, on the week and day that maximum service is provided (defined in the National Transit Database (NTD))
 - Excludes atypical days and one-time special events
 - Most recipients already report VOMS data to the NTD


Which bus transit modes are fixed vs non-fixed route?












Examples of Transit Providers that are not Small Public Transportation Providers

State DOTs and Agency Safety Plans

- State DOTs are responsible for developing ASPs for applicable small public transportation providers in their State
 - Regardless of State laws, State regulations, State resource constraints, common practices, etc.
- A State DOT is responsible unless a small public transportation provider <u>voluntarily</u> opts to develop their own plan AND notifies the State of their intent to do so
 - A State <u>cannot</u> require a small provider to opt out
 - Opt-out notification documentation should be maintained



State DOTs and Agency Safety Plans

- State DOTs could develop:
 - Individual ASP for each small provider
 - A single ASP that addresses all requirements for all small providers in the State
- State DOTs and small providers could collaborate to develop plans
 - For example, a State DOT could develop a template and collaborate with small providers to create individualized ASPs



State DOTs and Agency Safety Plans

 Regardless of whether the State DOT or the small public transportation provider develops the ASP, the transit provider is required to implement the plan



Developing an ASP Frequently Asked Questions

I'm a contractor providing transit service to a transit agency. The transit agency receives Section 5307 funding. Do I have to develop an ASP?

Not necessarily. The PTASP regulation does not require contractors to develop their own ASP.

- The Section 5307 recipient or subrecipient is responsible for fulfilling PTASP requirements, including developing an ASP
- The recipient or subrecipient may require you to develop and/or implement the ASP on their behalf
- Ultimately, the recipient or subrecipient, not the contractor, is responsible for complying with PTASP requirements
